SUBJECT: 55th Wing High Risk Travel List: Week of 27 July 2020

1. Table 1 contains the list of 55th Wing high risk travel areas for the week of 27 July 2020.

Table 1: 55th Wing High Risk Travel Areas

2. These areas are assessed to be at high risk for COVID-19 exposure based on a number of factors, including but not limited to:

- a. Effective rates of transmission for each area (Rt score)
- b. Slope of infection rates for each area
- c. Centers for Disease Control and Prevention (CDC) predictive forecasting, COVID tracking, and Travel Health Notices
- d. Federal Emergency Management Agency risk factor score
- e. DoD Travel Information App
- f. AFIT COVID-19 Health Assessment Tool

3. Please note that this list is applicable to CONUS travel Quarantine only; it does not apply to ROM from OCONUS travel or for disease related Quarantine and Isolation.

4. Members who have any symptoms consistent with COVID-19 upon return from travel, will automatically go into Isolation and should contact the MTF for further guidance.

5. This list does not apply to critical healthcare workers based on Centers for Disease Control and Prevention, and Nebraska Department of Health and Human Services guidance.

6. This list is to be used in conjunction with the Travel Risk Assessment Calculator to assist Commanders in risk evaluation and recommendations for restriction to quarters for 14 days of Quarantine for High Risk travel exposures. Additional risk assessment tools are available
