The purpose of the proposed modification is to revise the remedies in the current permit at OT018 requiring the Air Force to place deed notifications on off-site property that the Air Force or Department of Defense does not own. The Air Force is proposing an alternative process to visually inspect and conduct a records review to ensure no domestic drinking water wells have been installed in the previous year on affected off base properties, the results of which will be reported to affected off base andowners. If the proposed modification is approved by EPA Region 7, the permit would no longer require deed notifications for OT018, but would require letters of notification to affected off base landowners near OT018, SD041, LF012, and SS040. The permittee's compliance history during the life of the permit being modified is available from EPA.
